No gambling.

No inflatable bouncy houses, slides etc.

Renter Responsibilities

Renter is responsible for any damage to the facility or Club property caused by any person.

Renter is responsible to leave the facility and surrounding areas clean and free of trash and debris.

Renter is responsible to leave the club facility locked with all windows closed and the security system activated.

Renter is responsible to close and lock the front access gate.

Renter agrees not to copy keys and FOBS and to return all keys and security system FOBS within 24 hours.

During Member rentals members must be present for duration of rental

Cancellation of Agreement

Cancellation of this agreement with 30 days’ notice or more will result in a full refund of fees.

Cancellation of this agreement with less than 30 days’ notice will result in forfeiture of all fees.

Other Conditions

The Club reserves the right to allow its members simultaneous use of the rifle range during any rental excepted weddings .

The club strives to maintain access to the facility during winter months and during storms or inclement weather. If access cannot be maintained the limit of club liability shall be to the amount of rental fees only.
